CALENDAR

- Application must be **RECEIVED** no later than March 9, 2007
- Notification will be emailed by March 16, 2007
- Exhibition dates: March 28, 2007 until May 26, 2007

ELIGIBILITY

- Open to ceramic artists worldwide.
- **Only** artists working in **CLAY** are invited to apply.
- The artist's work must exemplify clay as applied art or clay as fine art or clay as both applied and fine art.

RULES

- Can enter up to three pieces
- All exhibited work must be for sale
- Work which differs from the submitted images will be disqualified
- **Do not submit work that is unavailable.**
- Non adherence to rules may be cause for disqualification

ENTRY FEE

- \$35 for 3 entries (non refundable)

COMMISSION

- 50% commission will be charged on all sales

FREIGHT AND INSURANCE

- The artist is responsible for freight and insurance on the work to and from Gloria Kennedy Gallery. The artist must include return shipping and insurance with the original art work. The gallery will charge \$25.00 a day for unclaimed artwork and will dispose of the artwork two (2) weeks after the closing of the exhibition.
- The gallery is responsible for insurance during the exhibition.

IMAGE REQUIREMENTS (SLIDES OR DIGITAL)

- Slides must be 35mm color in cardboard or plastic mounts

Label each slide with:

- artist name
- HxWxD (in inches)
- title of work
- A or B or C to coincide with entry
- an arrow to show the top of the slide

- Digital image must be in jpeg or tiff format on CD

- CD case must be labeled with the above information about each piece.
